

TERMS AND CONDITIONS OF GRANT

- (i) The accounts of the grant(s) will be open to check by the Comptroller and Auditor General of India at his discretion;
- (ii) The grant(s) should be utilised within one year from the date of issue of the sanction and unspent balance(s) if any, should be refunded immediate thereafter;
- (iii) The grantee(s) will abide by other conditions imposed by the State/Union Territory Government and the State Sports Council from time to time;
- (iv) A Bond in the form enclosed, will be executed by the grantee(s) for fulfilment of the conditions of grant(s) and will be sent to the Union Government without which the grant will not be disbursed.

presently working as (*designation in the grantee institution*) do hereby undertake to do the following for and on behalf of the grantee).

2. That I am aware of the Scheme of “State Sports Academy” of the Central Government.

3. That Ministry of Youth Affairs & Sports of Central Government has sanctioned an amount of Rs. ----- (Rupees-----) under the aforesaid scheme in favour of ----- (Name of the grantee) vide letter No. ----- dated -----.

4. I have gone through the contents of the aforesaid letter containing the terms and conditions for the grant.

5. That I shall unconditionally abide by all the terms and conditions for the sanction of the said grant as contained in the aforesaid sanction letter.

6. That quarterly progress reports clearly indicating the items of work completed and expenditure incurred thereon, will be forwarded by me to the Union Government regularly till the completion of the project.

7. That after completion of the project, I shall furnish statements of income and expenditure in respect of the project duly certified by Chartered Accountants along with Completion certificate duly certified by an Engineer mentioning that the project has been completed in accordance with the original plans and estimated and if there has been any deviation in the plans and estimated originally submitted to the Union Government, reasons/justifications therefore will be furnished.

8. That the construction work, etc shall be carried out through a Contractor only after inviting tenders in accordance with the established practice.

9. That the minimum area required for the project for which grant has been sanctioned is available and is in possession of the grantee.

10. That the assets acquired wholly or substantially out of the Government grant shall not without the prior permission of Government, be disbursed off or encumbered or utilised for any purpose other than those for which the grant has been sanctioned.

11. That all write-off and losses etc. on assets and the rates of depreciation shall be got approved by the Government of India.

12. That the Union Government has right to claim share of rent, where the project assisted is used for purposes other than the purposes for which grant is given.

13. That the grantee shall utilise the assisted sports infrastructure for sports and games purposes, and make available to the State/Union Territory Government and the State Sports Council the facilities on terms and conditions decided by the management if and when required.

14. That in addition to the information/documents, required to be submitted in accordance with the above mentioned sanction letter, the grantee shall also submit any other relevant information/documents as called for by Union Government and the State Government.

15. That in case of non-observance of the aforesaid terms and conditions, the Union Government shall have liberty to cancel the said grant and call back the refund the same to the Union Government without any delay.

16. That in case of cancellation of grant the grantee shall refund the same to the Union Government without any delay.

17. That in case of failure to refund of the said grant, the Union Government shall have right to recover the said grant from the grantee as arrears of land revenue or in the manner deemed fit by the Union Government
